

Information on data protection for participants in the Seventh International Conference on Uniform Distribution Theory (UDT 2020)

On this page, you receive information about the way and for what purpose we process personal data in the course of the conference. In addition, we inform you about your rights in connection with the processing of your data.

The conference is organized in cooperation between the Österreichische Akademie der Wissenschaften (Austrian Academy of Sciences) and the Johannes Kepler Universität Linz (Johannes Kepler University Linz). Legal Basis and Purpose for Data Processing

The legal basis of processing your data is your registration for, your participation in and the performance of the conference (Art 6 (1) b GDPR), the compliance with legal obligations (Art 6 (1) c GDPR; accounting obligations) or a legitimate interest (Art 6 (1) f GDPR, performance and documentation of the conference) of the organizing organizations.

Your data will be processed for the administration of the conference (including registration, accommodation and travel arrangements, billing etc.), to provide you with information about (e.g. changes, deadlines, location) and documents of (e.g. program, proceedings) the conference as well as for the documentation of the conference (including photos).

Data categories

We process the following categories of data:

Identification data (name, gender, affiliation), contact details (e-mail address), payment data, travel data (arrival and departure day and, if necessary, processing data for the hotel booking, if this was requested)

Recipients

Your data will be forwarded to a payment service provider for the payment processing as well as to hotels, (if booking was requested).

Retention Period

Your data will be stored as long as necessary for the administration and documentation of the conference or legally requested or permitted.

Your rights

You have the right to request access to and rectification or erasure of personal data or restriction of processing or to object to processing as well as the right to data portability. Furthermore, you have the right to lodge a complaint with the competent supervisory authority in Austria or another EU member state. The Austrian supervisory authority is:
